### SCOPE OF WORK

# Subject: Repairing/Renovation of Garden and Street light Poles at CSTARI Campus.

SL. No	Description	Quantity
1.	The Garden and street lighting poles which are badly damaged (by rust & corrosion) its bottom portion are to be repaired by fixing steel plate 1' height X ½" thick cylindrically and fastened by welding. After welding 3 nos angel Iron 2" X ¼" X 1 ½" length are to be welded vertically by its periphery in equally spaced. The entire repaired portion are to be finished by synthetic primer and coated by synthetic enamel paint.	50 nos
2.	making new collar cylindrically 3' height X 2' diameter made of concrete with a ratio of 5/8" Stone chips, Coarse sand and convent (2 1/2 2 1) followed to	60 nos
3.	Supply & fixing Garden and street light pole box (Syntax SMC Join Box Model No-GSDB3020 Size-290X195x100) to be inserted/ installed by "U" clamp above pole collar where in connection to be done by inserting 2 nos. Aluminium Bar 10" x 2" x ½" thick and 1 nos Fuse. And power supply to be connected by socket with underground cable which is to be digging out from soil/land. The cable is to be covered by PVC protection pope.	51 nos
4.	All finished Garden and street light poles and collars are to be painted by cement primer followed by synthetic enamel paint, Poles to be rubbish by MRE paper and apply the rush proof enamel primer and 2 coat metallic paint.	68 nos
5.	Suppling and laying 2X16 sq mm XLP aluminium Armor Cable are to be connected by laying cables underground by digging soil 2 ft. wide & 3 ft. deep. The cable are to be covered by sand 6" thick followed by brick layer 10" above sand.  Finally the surface to be levelled by filling soil. Connected by aluminium socket & gland with accessories	300 miters
6.	Supplying and fixing street light- Green line smart type LED cool white 2000lm (25 W) (Make – Philips) Type no BRP 020.  NB: with complete fitting – GI Pipe Ø 1 ½ "bend with suitable angel, to be fitted on existing pole with nuts & bolts. This extended portion to be painted with primer (Red oxide) & synthetic enamel silver paint. The fittings are to be connected by 3 x1.5 mm <sup>2</sup> copper conductor.	06 nos
